(Privacy Statement)

The Department of Housing, Local Government and Heritage is the Government

The Department is committed to protecting and respecting your privacy. This privacy statement explains how the Department, as the Data Controller, will process the personal data provided to it in respect of registration for, and attendance at, the 1954 Hague Convention 70th anniversary conference; how that information will be used, and what rights you may exercise in relation to your personal data.

Categories of personal data

Note: Attendees at the conference will be informed that photography and video recording will be in use so that they can opt out if they wish. This privacy statement will also be made available to attendees on the day and beforehand on Eventbrite.

Purposes of the processing

The Department will use the information provided in order to facilitate attendance at the 1954 Hague Convention 70th anniversary conference, and to promote the event through photography and filming.

Profiling

The Department will not use any personal data collected from you in respect of the 1954 Hague Convention 70th anniversary conference for automated decision-making, or for profiling purposes.

Lawfulness of processing

This processing of your personal data is lawful under Article 6 (1)(e) of the GDPR, which provides that processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller, and Section 168 of the Historic and Archaeological Heritage Miscellaneous Provisions Act 2023.

Security of your personal data

The Department implements appropriate technical and organisational measures to protect your information from unauthorised access. However, despite these efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse. In the event that your personal data is compromised as a result of a breach of security, the Department's Breach Management policy and procedures will be implemented.

Recipients of the data

Personal data may be shared internally for audit or other compliance purposes.

Personal data may be shared with other Government Departments, local authorities,



agencies under the aegis of the Department, or other public bodies, in certain circumstances where this is provided for by law.

Cross-border Data Transfers

Transfer of your personal data may occur outside of the European Economic Area (EEA). Where it is required to do so, we will only transfer the data when an adequate level of protection to the treatment of your data is ensured.

How long will your data be kept?

The Department will only retain your personal data for as long as it is necessary for the purposes for which it was collected and processed. In line with legislative and business requirements, the data retention period for your personal data, in this instance, is 1 year after the conclusion of the 1954 Hague Convention 70th anniversary conference.

Your rights

The Department's <u>Data Protection Policy</u>, which sets out how we will use your personal data, as well as providing information regarding your rights as a data subject (including details regarding right of access, right to rectification, right to erasure, right to restriction of processing, right to object), is available on our website.
